Our organization offers a wide variety of therapeutic and support services to eligible infants and toddlers with developmental delays and disabilities. We also provide family education, counseling, and home visits.

If you are concerned about your child's development, PM Evaluation & Therapy Services will create and complete the referral for your child in the NY State Early Intervention System (NYEIS).

Facts about the NYC Early Intervention Program

The Early Intervention Program (EIP) is a public program that offers services to children under age 3 with a suspected or diagnosed developmental delay or disability.

Children with diagnosed conditions that lead to developmental delays (such as Down's Syndrome, Cerebral Palsy, Autism, Communication disabilities, etc.) are eligible for the EIP.

Children with no diagnosis who have delays in development may be eligible for the EIP if their delays are negatively impacting their development.

If you have concerns about the development of your child, seek help. The earlier an issue is detected, the better it is for your child.

Your child's health insurance may be used to cover some of the cost. All others costs for EIP services are paid for by your county and New York state.

Eligibility

A child's eligibility is determined only by New York State approved evaluators under contract with the county. Additionally, all services must be authorized by the county EIP.
